The Real Estate Services Survey Section of the County of San Diego Department of General Services is processing a request by Indian Head Ranch Homeowners Association to vacate (relinquish the public interest) in various roads located within Indian Head Ranch Road. The roads are Coyote Way, Anza Park Trail, Horseshoe Road, and Indian Head Ranch Road. Please see attached Vicinity Map.

The purpose of the proposed vacation is to enhance residence security and safety by allowing the residents greater control over access to their community. Private road easements have been granted the various owners within Indian Head Ranch Road and no owner will be denied access by this action. Please note this is a revised request intended to vacate only the roads within Indian Head Ranch Road. This proposal supersedes a previous request that included vacation of roadways outside the boundaries of Indian Head Ranch Road.
